



**NOTICE OF PUBLIC MEETING**  
**United States Highway (US) 380**  
**Proposed Improvements to US 380**  
**from Farm-to-Market (FM) 1827 to County Road (CR) 985**  
**CSJs: 0135-03-050, 0135-04-034**

The Texas Department of Transportation (TxDOT) will conduct a public meeting for the purpose of soliciting comments on proposed improvements to US 380 from FM 1827 to CR 985 in Collin County, Texas, a distance of approximately 8.4 miles. **The meeting will be held on Thursday, May 31st, 2018 from 6:00 pm to 8:00 pm at Princeton High School Cafeteria, located at 1000 E. Princeton Drive, Princeton, TX 75407.** Representatives from TxDOT and project consultants will be available to answer questions about the proposed project. **The meeting will be held in an open house format from 6:00 p.m. to 8:00 p.m. with no formal presentation.**

The US 380 proposed improvements would include the installation of a 15-foot raised concrete median with intermittent openings within the project limits, in place of the existing flush median. All work is proposed within the existing right-of-way (ROW).

Maps depicting the proposed project's location and preliminary geometric design will be available for viewing at the public meeting. This information is also available for public inspection at the TxDOT Dallas District Office, 4777 East Highway 80, Mesquite, Texas 75150, and at the TxDOT Collin County Area Office, 2205 South State Highway (SH) 5, McKinney, Texas 75069. All interested citizens are invited to attend the public

meeting. Written comments from the public regarding this project are requested and will be accepted for a period of 15 calendar days following the public meeting.
