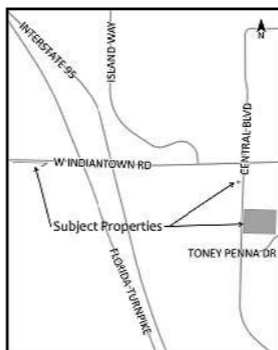
The Town of Jupiter proposes to adopt the following resolution on **Tuesday, October 16, 2018**:

## RESOLUTION 80-18

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF JUPITER, FLORIDA, AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN PALM BEACH COUNTY, FLORIDA AND THE TOWN OF JUPITER, FLORIDA REGARDING THE ANNEXATION OF 26.9+/- acres of unincorporated land containing 256 condominium units, a 0.3+/- acre unincorporated property and one right-of-way parcel PURSUANT TO SECTION 171.046 FLORIDA STATUTES AS LEGALLY DESCRIBED IN THE ATTACHED EXHIBITS "A" AND "B"; AND PROVIDING AN EFFECTIVE DATE.
